

WESTERN PROVINCE BISLEY ASSOCIATION COVID-19 CODE OF CONDUCT



The Western Province Bisley Association (WPBA) is doing its part to ensure all preventative measures are in place to reduce the spread of the virus and to ensure that all legal, health and safety requirements for sport events are adhered to.

All shooters are hereby required to sign this *Code of Conduct* in agreement to the terms and conditions to participate in training and matches and adhere to control measures put in place. Signing this *Code of Conduct* is only required once before resuming shooting activities and the signed documents must be sent to the Secretary of the WPBA for record.

I, as prospective participating athlete of this sport confirm and agree to the following terms and conditions:

1. Understand and agree to the communication and measures shared by the Compliance Officer prior to commencement of training and matches to comply with this Regulation and the spread of COVID-19. These conditions include:
 - a) Pre-Match / Training Medical Compliance: Temperature screening upon registration process.
 - b) Stadium Compliance: Social distancing in ablution and clubhouse facilities.
 - c) Team Compliance: Personal hygiene, protocol communications upfront and information shared.
 - d) Field-based Compliance: Social distancing and food arrangements as stipulated.
2. Agree to submit the *Self-Assessment Health Questionnaire*, completed at home, upon registration on the day of the event. A separate *Self-Assessment Health Questionnaire* must be completed for every event. This needs to be completed and emailed to the respective Compliance Officers by the **Wednesday before each event**.
3. Understand that the Provincial and Club Committees need to ensure that high-risk shooters are identified during registration on the day, by means of screening and evaluating the high-risk questionnaire for shooters.

I further declare that:

4. I am aware of COVID-19 and the virus causing it, how the virus is spread, the symptoms of the disease and how I can protect myself against infection.
5. I know of and abide by the current lockdown regulations, particularly wearing a cloth mask in public, maintaining physical distancing of >1.5 meters, respecting travel restrictions and curfews.
6. I monitor my own health for early COVID-19 symptoms or flu symptoms.
7. I know the protocol to report should I or someone in my household, become ill with any of the symptoms associated with COVID-19.
8. I am aware of the COVID-19 protocols in place for training and matches:
 - a) I received formal communication regarding event protocols
 - b) Compulsory temperature screening upon registration

- c) Wearing of re-usable cloth masks
- d) Frequent washing of hands with soap and water and use of hand sanitisers
- e) Physical distancing (> 1.5 metres)
- f) Coughing and sneezing within a tissue (to be disposed) or within elbow
- g) Each person to use disinfectant to clean own equipment
- h) No sharing of equipment and stationery
- i) High frequency cleaning of communal areas and ablutions

9. **I acknowledge that should I breach this Code of Conduct, I might be subjected to disciplinary action by the WPBA.**
