Skiereiland Skiet Liga (Peninsula Rifle League)

Rules and Regulations Governing League Shooting Competitions

1 Organisation

The league shall be governed by the Western Province Bisley Association (Herein after referred to as the WPBA) Committee

2 General

SANRA Rules and regulations which govern target rifle shooting will be applicable and will be enforced at all times. Safety regulations are of paramount importance.

3 Eligibility

Only clubs which are affiliated to and are in good standing with the governing body will be allowed to enter teams in the league competition.

An individual may only take part in the league's competitions if a member of an affiliated club.

Affiliation fees and entry will be set by the WPBA Committee.

NB Team affiliation and entry fees must be paid before commencement of a competition.

4 Competitions

League matches will be fired on a monthly basis. A program for the year will be drawn up by the Committee and this will be adhered to as far as possible.

In the case of team shoots, the format of the league as to the number of sections, their size and composition and type of competition plus the number of members per team will be determined by the committee before the commencement of the first league team shoot of the year.

An individual league championship consisting of 3 stages as well as spoon shoots where appropriate will be organised.

5 Squadding

Teams from each respective section will be squadded in one group together.

6 Register Keeping

Teams will supply register keepers for each other.

7 Coaching

Club members not required for other duties may assist their teams in other sections but this must not cause delay.

8 Range Officers

Clubs will be required to supply range officers on a rotational basis and the duty roster will be circulated with the program.

The range officer will decide on any problems which may arise during a competition. Should his/her decision be disputed the matter will be decided by the range committee.

9 Time Allowed

All teams will commence firing when given the "ALL CLEAR" by the range officer and after the expiration of the allotted time for the distance being fired all targets will be lowered.

Should teams not have fired all their shots at the end of the time allocated, the range officer may allow these shots to be fired if he/she considers that circumstances justify. In the event of a dispute the additional shots will be fired but only be allowed to count should the range committee so decide. Range officers must liaise and synchronise their time with the secretary before shooting commences.

The time allowed per range will be as follows:-

Short ranges (300,500 and 600m)

The number of minutes equal to the number of shots required plus 25%.

Long ranges (700, 800 and 900m)

The number of minutes equal to the number of shots required plus 33.33%.

10 Teams

The number of members per team and where teams are unable to be at full strength on any occasion, the table as illustrated in 10.2 will apply in conjunction with clauses 10.3 and 10.4. For 19 and 15 members the club will have a choice.

Clubs which enter only one team in the league must be at full strength (6 members) for 50% of team competitions. Where a club has only 5 members available at a team shoot (subject to the 50% rule) then the lowest score will count for the 6^{th} score.

10.4 In the case of B and C teams, the number of scores to count will be five. Where such a team has six or seven members, the top five scores will count for the team total. Where B and C teams have only four members then the lowest of the four scores will count as the fifth score for the team total

11 Club Members not in Teams

On every league fixture day one or two targets will be available for club members not in teams who may make use of these facilities on payment of markers fees.

12 Score Cards

Team captains must ensure that the score cards are correct and complete in every detail i.e. all scores must be entered, totals written in and signed by the team captain and range officer.

Failure to comply will cause disallowance of the entire score.

13 Members of Teams

A member may only represent one club in the same year.

14 Rules and Regulations

The rules and regulations of the league may not be changed by any outside organisation unless decided by the committee.

These rules and regulations apply for 2006.
